- Oneok Presentation
 - Joe Lehman from Oneok Pipeline gave the group a presentation on their emergency response capabilities.
- Old Business
 - The minutes from the September 24th, 2013 meeting were approved.
 - Assistant Johnson County Attorney Susie Nehring had looked into whether or not a county-wide fee ordinance for Tier II and EHS facilities could be adopted that would eliminate the .50 per capita from the taxpayers. She advised that it would not be possible to draft a county-wide fee ordinance. The letter from Susie will be sent with the minutes explaining the reasons.
- ESF 10 plan review and Cameo updates/status reports. (BJ)
 - The ESF 10 Hazmat Plan was sent out to the group for review. A few revisions were noted at the meeting but if there are any others please let B.J. Dvorak know by April 15th so he can make the changes.
- Haz Mat Team report or areas of concern-Brian
 - On January 21st the hazmat team responded to I-80/265 MM in Cedar County for a semi that rolled over and was leaking diesel fuel.
 - There are currently 26 members on the Hazmat Team.
 - Two team members are currently on extended injury leave.
 - All team members have completed and passed their annual testing.
 - Two of the team members attended a federally funded radiological class in Mercury, Nevada.
 - Two of the team members will be attending a grant funded hazmat technician class in Lansing, MI this summer.
 - Some equipment has been updated on the truck.
- State Report-DNR if present.
 - No one from the DNR was present.
- EPA Region 7 report if present.
 - No one from EPA Region 7 was present.
- Public Health Preparedness Healthcare Coalition Update – Tricia & Other Coalition Members
 - Iowa is still under development with getting its healthcare preparedness coalition started. Cedar County has joined over the last 8 months. Washington County has also expressed
