Army Corps of Engineers to increase reservoir outflow

Johnson County, Iowa – The U.S. Army Corps of Engineers Rock Island District has notified Johnson County Emergency Management that it intends to begin increasing the amount of water released from the Coralville Lake Reservoir. Beginning today, the Corps will increase the outflow on the Iowa River from a current rate of 10,000 cubic feet per second (CFS) to an anticipated level of 12,000 CFS. This outflow of 12,000 CFS will remain in effect until the Coralville Lake starts to fall more than one foot per day.

The National Weather Service reports that the area is coming out of a wet cycle. There will be small amounts of rainfall in the area over the next 24 hours, but there is no rain forecasted for the next seven days.

“Obviously this is good news with predicted lake elevations dropping below 711 feet and outflows decreasing to less than 13,000 CFS from the dam. No mandatory evacuations are anticipated due to these changes,” said Johnson County Emergency Management Director Dave Wilson.

Those downstream from the Coralville Reservoir can monitor changes at www.rivergages.com. Emergency Management will continue to monitor weather conditions and water levels in order to assist emergency response throughout the county. Johnson County Conservation has closed the Hills Access near the city of Hills and the River Junction Access in southern Johnson County due to flash flooding and the rising water dangers of the Iowa River. These areas will remain closed until further notice.

Johnson County Emergency Management has recommended voluntary evacuation for locations in unincorporated Johnson County on Camino Del Rio SE, Driftwood Lane SE and Ocean Boulevard SE. Mandatory evacuations of these properties may be ordered in the future, depending on flows at the Burlington Street gage. There are presently no other voluntary or mandatory evacuations for anywhere else countywide.
